You may send your entry any time after the opening date (postmarked) and you must send it no later than closing date (postmarked). Tests and rules can be downloaded at www.wdaa.org.

Ride times: Will be sent via e-mail unless otherwise specified.

Refunds: Up to closing date, fees will be refunded except office fee. From day after closing to day prior to competition, class fees will be refunded only if ride(s) can be filled from wait list. During the competition no refunds including for 'Acts of God' will be issued. **Office fee is non refundable.**

Awards: Ribbons to 5th place all divisions. Management reserves the right to break ties.

Directions: Judge's Choice Training Center; 6771 Highway 79, Bennett, CO 80102: Take I-70 to Bennett exit 304, exit north onto CO-79 toward Bennett & Prospect Valley. Go between grain elevators, cross the railroad tracks and bear right to Highway 79 approx. 6 miles. Destination is on the left (west) at the top of the small hill. Trailer parking is available in the field behind the barn.

Warm-up: Available in the indoor arena or beside the outdoor show arena.

An ASTM safety helmet is required at all for Western Dressage competitors UNDER the age of 18. Boots with heels are required for all competitors.

Concessions: Water and limited concessions will be available.
